Amending some of the Executive Regulations of the Social Housing Law

In pursuance of Royal Decree No. 3/2008 on establishing the terms of reference of the Ministry of Housing and approving its organizational structure;

And, the Social Housing Law promulgated by Royal Decree No.37/2010;

And, the executive regulation of the Social Housing Law issued by Ministerial Decision No.6/2011;

And, the approval of the Ministry of Finance via its letter (No. Finance-T (5037) M.T.D/6/3/2011 dated 13/6/1432 A.H, corresponding to 17/5/2011 A.D;

And in Pursuance of the Public Interest;

The following has been decreed;

Article 1

With reference to the executive regulation of the Social Housing Low, the attached amendments shall be made.

Article 2

All that contradicts with this Decision or contravenes with its provisions shall be cancelled.

Article 3

This Decision shall be published in the Official Gazette and shall be effective from the day following the date of its publication.

Amendments to some Provisions of the Executive Regulations of the Social Housing Law

The texts of Articles 3 (item D), 4 (item E), 5, 15, 21, and 36 of the Executive Regulations of the Social Housing Law referred to, shall be replaced by the following text:

Article 3, item (D)

A woman who is married to a non-Omani and who has minor children living with her in the Sultanate of Oman continually and permanently, provided that the husband's monthly income shall not exceed RO (300/-).

Article 4, item (E)

A working woman who is married to a non-Omani and who has minor children living with her in the Sultanate of Oman continually and permanently, provided that the couples' total monthly income shall not exceed RO (400/-) at the time the application is made.

Article 5

In order to obtain a residential unite, the monthly income of the husband and the wife shall not exceed RO (400/-).

Article (15)

The total monthly income of the housing support applicant shall not exceed RO (300/-) at the time of submitting the application and the arrival of his/her turn.

It is required that the monthly income of the housing support applicant who is over 60 years, shall not exceed RO (400/-).

Housing support may be conferred to those who did not benefit from a housing loan due to exceeding 50 years of age, on a condition that their monthly income shall not exceed RO (400/-) at the time their turn arrives.

Article (21)

The total income of the applicants for housing loan shall be between RO (301/-) and RO (400/-) at the time of registering the application. The total income of the applicants when their turn comes shall not exceed RO (500/-). In case the wife has a job, the total monthly income of both shall not exceed RO (600/-).

Article (36)

The Minster may, after the approval of the Ministry of Finance, exempt the loan beneficiary from paying the installments of the loan when his/her monthly income decreases after being conferred the loan to less than RO (300/-) in the light of the result of the study conducted in this respect.
